Membership in the Mach 5 Flying Club affords Member use of aircraft at the Membership discounted rate, 10% off of all Mach 5 merchandise, VIP invites to Mach 5 Safety Training and other aviation events.

## MEMBERSHIP DUES AND SCHEDULE:

- > \$100 Initiation Fee
- ➤ \$35 Monthly Membership Dues (individual) or
- ➤ \$50 Monthly Membership Dues (family, up to four direct family members)

Member is making an application to Mach 5 Flying Club, and such application has been duly approved. In consideration of the regular payment of dues and other charges billed to the member and of the covenants, terms, and conditions of this Agreement, it is mutually agreed that:

- 1. Member shall be entitled to engage in all flying activities and to use the aircraft in accordance with the rules and regulations provided.
- 2. It is agreed by the Member that he/she will indemnify, protect and hold harmless Mach 5 from all claims, demands, causes of actions, suits or costs whatsoever asserted by any person, firm or corporation arising from the operation of the aircraft by Member, specifically including, but not limited to, operation in violation of any United States Federal Aviation Regulations or Mach 5 Policies and Procedures.
- 3. Member further agrees to pay Mach 5 Flying Club membership dues no later than the 5<sup>th</sup> day of each month commencing on the date below, via auto-pay, or auto-bill (non-prorated) and after each flight to pay for all rental and other incurred costs, as included in the current Mach 5 rate sheet, which is subject to changes by Mach 5 from time to time, with notice
- 4. If the Member fails to pay any money due in connection with rental of aircraft, according to the Payment Policy in the Standard Operation Procedures (SOP), Mach 5 may suspend Membership and flying privileges. This agreement shall be binding upon the heirs, legal representatives, and successors of the parties hereto.
- 5. Term and Termination: This Agreement shall be for 12 months, renewing automatically for 12-month periods, unless Member gives 30 days notice Not to Renew. Either party may terminate this agreement with 30 days notice to the other party.
- 6. Suspension: Member may, with 30 days notice to Mach 5, suspend Membership for up to 12 months, if it is reasonably known that Member will be unable to fly or rent, due to travel, medical, family care, financial, or other grounds. Member may resume Membership at any time up to 12 months. If Member is inactive for over 12 months, Mach 5 may treat reactivation as a new Membership and charge the Initiation fee again.
